As early as April 2026, producers must demonstrate a path toward achieving compliance or face future penalties and bans with fines reaching up to \$18 million.

To successfully demonstrate that FFP has a scalable pathway to recyclability, The Recycling Partnership is collaborating across the industry to demonstrate what it will take to increase FFP capture in California.

**The CalFFlex plan leverages findings from nearly 50 FFP interventions to date, as well as more than 30 investments in California to support various materials.**

## A \$5 million investment in the recycling system, with emphasis on end markets, is needed to help build a pathway to compliance for FFP.

- FFP recycling in California is an all-hands-on-deck moment: the entire value chain, from brands and retailers, to reclaimers and manufacturers, are needed at the table
- CalFFLex is supported by nearly 20 companies today, but additional funding is required to implement the full three-part strategy
- Once the blueprint is developed, it will be clear where end market investment is needed to sustain future FFP volumes
